1 CALL TO ORDER

Mayor Rinde called the meeting to order at 5:00 p.m.

T. Dann spoke about the cost associated with his special assessments on his property. T. Dann asked the council if there is anything they can do to reduce the price as T. Dann doesn't believe that the assessment is fair. Council member R. Dostal stated that the council members are not engineers and this is a question for Widseth, and T. Dann should ask them on how they came up with the assessed price. Council stated they would look into this situation but nothing would happen this year as the assessments have already been submitted to the County.

7 NEW BUSINESS

a) Laura Hill property

Mayor Rinde gave the council an update on the blight court hearing that was held against L. Hill. After the hearing the judge determined that it states in the

City of Badger ordinance the word "and" therefore the judge decided that L. Hill was found not guilty of her blight charge, as L. Hill's blight charge was for inoperable vehicles and for her to be noncompliant she had to be noncompliant with more than one blighting factors. The City will be going through the ordinances and sending them to the City attorney to review. They City of Badger following their protocol at the time time had L. Hill's vehicles towed to Badger Towing and Storage. Upon the determination of the not guilty charge the City of Badger has met with Badger Towing and Storage and will pay a reduced fee for the charges that have occurred from storage and towing of L. Hills property. L. Hill will need to get in contact with Badger Towing and Storage to retrieve her property.

b) Review of Ordinance

c) Application for part-time snow removal

Motion was made by council member A. Gregerson to hire Trent Byre for the position for PT snow removal seconded by council member C. Christianson, U.C

d) User Fees

Council discussed last months rate increase on sewer fees. After looking over the numbers and what is needed to maintain a surplus for this account, the council was in agreement that the fee for sewer can be reduced to \$42.00/month. This decrease will go into effect on the March 2025 utility billing. Motion was made by council member C. Christianson and seconded by council member G. Lee to reduce the sewer rate from \$47.00/ month to \$42.00/ month, U.C

Motion was made by council member A. Gregerson to approve and amend the Badger Fire Relief Bylaw to change the yearly retirement distribution from \$500.00/year to \$700.00/year motion was seconded by council member R. Dostal, U.C.

Morris Vacura gave the council an update on how the the donations to and progress of the Badger Veterans Memorial Wall is coming. Morris stated that it all depends on what kind of Spring we have but the committee is hoping to have this project completed by Memorial Day.

More meetings to be held in March with more stakeholders within the county to decide on what towns, areas, ideas for improvements are needed.
