The City of Badger Council met in Regular Council on Wednesday, March 19, 2025 at 5:00 PM in the Badger Community Center 111 North Main St. .

1 CALL TO ORDER

Mayor Rinde called the meeting to order at 5:00 p.m.

3 APPROVAL OF AGENDA

Council reviewed the delinquent utility aged billing. Council discussed that when the Cold Weather Rule comes off in April, any resident that is 30 days behind will receive a door hangers giving them a date and time, along with their balance due, payable to the City Office by a certain date and time. Council discussed that each resident gets a utility bill monthly so this should be no surprise as to what they owe. If a resident pays by personal check, and their water has been tuned off, the City will wait until the check clears the bank to regain services to the resident.
